

Laborers Local 60 Apprentice & Training Fund *Joint Apprenticeship Training Committee*

Local 60 will distribute 100 apprentice application forms commencing **May 1st – May 14th, 2026** (or until the 100 applications are distributed) **between 8AM – 10AM** at the following location:

Laborers Local 60, **50 Prospect Hill Road, Brewster, NY 10509**

Applications will be distributed on a first come basis.

Applications must be returned by: May 26th, 2026.

NYS ID REQUIRED

The New York Department of Labor and the Joint Apprenticeship Committee require that all applicants:

- Must be at least 18 years old, as verified by a valid New York State ID.
- Must have a high school diploma or high school equivalency diploma (e.g. GED/TASC). **Proof required at time of submitting application.**
- Must have reliable transportation to and from work and related instruction
- Must sign affidavit attesting to work throughout the workday continually on his/her feet; to operate equipment, and lift and carry weights in excess of 80lbs. for extended periods; to distinguish color coded materials and supplies; to work through extended periods of extreme weather conditions and temperatures; to work in restrictive or confined spaces; to work at heights of 20 feet on a scaffold or platform; to work in ditches and trenches up to 20 feet in depth; to work in proximity to moving traffic.
- Must take a physical agility test conducted by Local 60, which includes: (a) dig a two (2) sq.ft. by one (1) foot deep hole with a shovel; (b) fill ten (10) sand bags with gravel and then carry each one fifty (50) feet; (c) break concrete/rock with a 60lb. pavement breaker for fifteen (15) minutes with no breaks; (d) load with a shovel ½ cubic yard of material into a wheelbarrow, wheel fifty (50) feet and deposit the material; (e) carry six (6) scaffold planks, one at a time, fifty (50) feet and place them on the scaffold; (f) carry ten (10) concrete blocks, one/two at a time, fifty (50) feet and stack them; (g) carry six (6) concrete forms, one/two at a time, fifty (50) feet and stack them.
- Must submit to a drug test prior to employment at the expense of the sponsor.

Applicants must also be available for and have transportation to day, evening, or Saturday Apprenticeship classes. Applicants are expected to successfully complete any class requirements prior to beginning work in the field.

Apprenticeship programs registered with the Department of Labor must meet standards established by the Commissioner. Under State Law, sponsor of program cannot discriminate against applicants because of race, creed, color, national origin, age, sex, disability or marital status. Women and minorities are encouraged to submit applications for the apprenticeship programs. Sponsors of programs are required to adopt affirmative action plans for the recruitment of women and minorities.
